- Tenants are not permitted under any circumstances to keep any dangerous dogs as included under Article 5.1 of the Control of Dogs Regulations, 1998. These are:

 - Doberman Pinscher

- every dog of the type commonly known as a Ban Dog (or Bandog) and every other strain or cross of every breed or type of dog described in Article 5.1 of the above Regulations.
- Pets are not permitted in apartments (with the exception of guide dogs, fish and certain birds)
- North & East will report all stray and unaccompanied dogs on their estates to the local dog warden service to arrange removal as per the provisions of the Control of Dogs Act 1986.
- If dogs are persistently roaming on the estate despite warnings to owners, the Association will withdraw the permission to keep the dog.

- Dog owners must ensure that dogs are kept on a lead at all times and not allowed to roam when in common/public areas.
- Pet owners must ensure that gardens are adequately secure to prevent pets straying
- Dog owners must not allow their dogs to foul in common or public areas
- Dog owners must not allow their dogs to bark persistently or cause other disturbance or disruption on the estate.
- Pet owners must not allow their pets to damage any part of North & East property
Domestic pets must not be kept for breeding purposes.
- Authorisation will be granted for a maximum of two dogs/cats per household.
- Failure to comply with any of these conditions will result in the withdrawal of permission and will be viewed as a breach of the tenancy agreement.

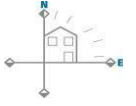
